Landlord Checklist

- Sign and return Clarke's Terms and Conditions, along with Identification and Proof
 of Address for all landlords
- 2. Complete Landlord NRL1 form then inform Clarkes of HMRC Approval Number (if applicable)
- 3. Ensure you have a minimum of three sets of keys cut to give to Clarkes
- 4. Ensure all safety certificates (EPC, GSC & EICR) are completed / remedials booked in
- 5. Install smoke detectors on each floor and CO2 alarm if applicable
- 6. Arrange buildings insurance / landlord rent cover
- 7. Make Clarkes aware of utility suppliers so accounts can be shut once the tenant has moved in (please note this will depend on service type)
- 8. Ensure property is ready for photos and inventory (instruct property clean if necessary)

If you are currently living in the property then please also complete the following....

- 9. Cancel broadband, tv license, contents insurance and any further subscriptions.
- 10. Organise for your post to be redirected
